General Requirements as indicated on Edwards Purchase Order

All items noted under the indicated section below shall apply to the specified purchase order in its entirety.

P-1 Steel Shapes and Steel Plates

All materials shall be purchased in accordance with ASTM A6. All materials shall be marked with the heat number and Edwards purchase order number. Material Test Reports are required with shipments. No material shall have China origin.

P-2 Steel Shapes and Steel Plates

All materials shall be purchased in accordance with ASTM A6. All materials shall be marked with the heat number and Edwards purchase order number. Material Test Reports are required with shipments. No material shall have China origin. All materials purchased shall meet the requirements of the "Buy America Act".

P-3 Steel Shapes and Steel Plates

All materials shall be purchased in accordance with ASTM A6. All materials shall be marked with the heat number and Edwards purchase order number. Material Test Reports are required with shipments. All materials purchased shall be Domestic only.

P-4 Fasteners

All materials shall be marked with the Edwards purchase order number and LOT number on both the top of the container and the lid if applicable. Certificates of Conformance are required with shipments, electronic as well if at all possible. No fastener materials shall have China origin.

P-5 Fasteners

All materials shall be marked with the Edwards purchase order number and LOT number on both the top of the container and the lid if applicable. Certificates of Conformance are required with shipments, electronic as well if at all possible. No fastener materials shall have China origin. All materials purchased shall meet the requirements of the "Buy America Act."

P-6 Fasteners

All materials shall be marked with the Edwards purchase order number and LOT number on both the top of the container and the lid if applicable. Certificates of Conformance are required with shipments, electronic as well if at all possible. All materials purchased shall be Domestic only.

P-7 Galvanizing

All iron and steel shall be hot dipped galvanized in accordance with ASTM A123.

P-8 Paint/Coatings

All paint and/or coating materials require certificates of conformance, product data sheets, and any other additional testing requirements if applicable.

P-9 Welding Filler Materials

All welding filler materials and fluxes shall be purchased in accordance with AWS A5.01M/SFA-5.01 stating the quantity, AWS specification, AWS classification, diameter, and length. Material Test Reports are required with all shipments. All packing must be marked in compliance with the latest revision of ASME BPVC Section II Part C SFA 5.02 para. 3.6. The minimum information required on welding filler material packaging shall be AWS classification and specification, supplier's name and trade designation, size and net weight, and LOT, control, or heat number. No welding filler material shall have China origin.

P-10 Welding Filler Materials

All welding filler materials and fluxes shall be purchased in accordance with AWS A5.01M/SFA-5.01 stating the quantity, AWS specification, AWS classification, diameter, and length. Material Test Reports are required with all shipments. All packing must be marked in compliance with the latest revision of ASME BPVC Section II Part C SFA 5.02 para. 3.6. The minimum information required on welding filler material packaging shall be AWS classification and specification, supplier's name and trade designation, size and net weight, and LOT, control, or heat number. No welding filler material shall have China origin. All welding materials purchased shall meet the requirements of the "Buy America Act."

P-11 Welding Filler Materials

All welding filler materials and fluxes shall be purchased in accordance with AWS A5.01M/SFA-5.01 stating the quantity, AWS specification, AWS classification, diameter, and length. Material Test Reports are required with all shipments. All packing must be marked in compliance with the latest revision of ASME BPVC Section II Part C SFA 5.02 para. 3.6. The minimum information required on welding filler material packaging shall be AWS classification and specification, supplier's name and trade designation, size and net weight, and LOT, control, or heat number. All welding filler materials shall be Domestic only.

P-12 Pipe and Fittings

All materials shall be purchased in accordance with the correct ASME specification / ASTM specification. All materials shall be marked with the heat number and Edwards purchase order number. Material Test Reports are required with shipments. No material shall have China origin.

P-13 Pipe and Fittings

All materials shall be purchased in accordance with the correct ASME specification / ASTM specification. All materials shall be marked with the heat number and Edwards purchase order number. Material Test Reports are required with shipments. No material shall have China origin. All materials purchased shall be Domestic only.
